**RE: Local Government Act 2001  
Bye Laws on Prohibition of Consumption of Alcohol in Public Places – April 2013**

A Chara,

I refer to the above Bye Laws which were approved by the Council in April 2013. It has been brought to the attention of the Council that the Bye Laws require to be amended following the abolition of Kilkenny Borough Council.

The schedule of towns to which the Bye Laws apply currently are listed overleaf. The Bye Laws are being discussed at Municipal District level during the December meetings and any other proposed amendments will be included in the revised draft Bye Laws for publication.

Subject to members approval, the draft Bye Laws will be put on public display for a period of one month in January and will be forwarded to Superintendents/Chief Superintendents operating in County Kilkenny, The Department of Justice and Law Reform and other relevant organisations. Following the public display period and having considered any submissions made members will be asked to adopt the Bye Laws not less than two months following the initial date of public display.

Having considered the matter at Municipal District level members are requested to approve these draft Bye Laws for public display in January 2017.

**Schedule to Kilkenny County Council (Prohibition of consumption of intoxicating liquor on streets and in public places) Bye-Laws 2013**

The parts of the functional area of Kilkenny County Council to which these bye-laws apply are as follows:

1. Ballyragget : That part of County Kilkenny comprising the Town of Ballyragget and it's environs as outlined in red on Map annexed hereto,
2. Bennettsbridge : That part of County Kilkenny comprising the Town of Bennettsbridge and it's environs as outlined in red on Map annexed hereto,
3. Callan : That part of County Kilkenny comprising the Town of Callan and it's environs as outlined in red on Map annexed hereto,
4. Castlecomer : That part of County Kilkenny comprising the Town of Castlecomer as outlined in red on Map annexed hereto ,
5. Ferrybank : That part of County Kilkenny comprising the Town of Ferrybank and it's environs as outlined in red on Map annexed hereto,
6. Goresbridge: That part of County Kilkenny comprising the Town of Goresbridge and it's environs as outlined in red on Map annexed hereto,
7. Graiguenamanagh: That part of County Kilkenny comprising the Town of Graiguenamanagh and it's environs as outlined in red on Map annexed hereto,
8. Inistioge: That part of County Kilkenny comprising the part of the townland of Kilcross as outlined in red on Map annexed hereto,
9. Kilkenny City Environs: That part of County Kilkenny comprising the City of Kilkenny and it's environs as outlined in red on Map annexed hereto, other than those parts thereof which constitute the functional area of Kilkenny Borough Council,
10. Mooncoin: That part of County Kilkenny comprising the Town of Mooncoin and it's environs as outlined in red on Map annexed hereto,
11. Piltown: That part of County Kilkenny comprising the Town of Piltown and it's environs as outlined in red on Map annexed hereto,
12. Thomastown: That part of County Kilkenny comprising the Town of Thomastown and its environs as outlined in Red on Map annexed hereto.
